

### News from the MSA President



Liability insurance is designed to offer specific protection against third-party **(another camper)** insurance claims, i.e., payment is not typically made for the insured **(FCRV and its members)**, but rather to someone suffering loss who is not a party to the insurance contract.

### 2021 CAMPVENTION UPDATE, Elkhorn, WI July 11-16, 2021



I've been watching for a Robin in my yard; a sure sign spring is just around the corner. With spring also comes graduation which is only a couple of months away. Time to think about completing your scholarship application and gathering the required attachments.

Scholarship deadline and requirements as follows:

- 1) Application deadline: June 1st
- 2) All applications mailed by U.S. mail must have a legible post office marked date stamp on the envelope to be accepted for judging. Applications emailed will be accepted by the date and time on the email.
- 3) Applicants must have a minimum 2.0 grade point average based on a 4.0 grading scale.
- 4) The applicant **or** applicant's parents must have attended at least one (1) Michigan FCRV campout in the previous year and camped/stayed overnight one night. The qualifying campouts are: MSA State Spring, MSA State Fall campout and a District campout.

Reminder: since all FCRV qualifying campouts (See item 4 above) were cancelled in 2020 due to COVID-19, the Scholarship board will waive the camping requirement for the 2020 camping season.

**IMPORTANT REMINDER**: Teens living at home planning to attend college or a trade school, upon turning 20 years of age, will need to request a 20-year-old honorary membership from the Michigan State Director to apply for a free membership. To be eligible for a National or Michigan FCRV scholarship, you must be a **member in good standing**. (See policy below)

Scholarship applications are available on the MSA website, <u>www.mifcrv.org</u>. Be sure to apply for a national scholarship; the contact information is at the bottom of the Michigan scholarship application.

### POLICY: TWENTY-YEAR-OLD HONORARY MEMBERSHIP

1. Any single child of an FCRV member in good standing, may at the age of 20, request of the State/Provincial Director that his/her name be placed on the 20-year-old honorary membership list. The name, address, and birth date of the 20-year-old will be provided to the national office through the State/Provincial Directors.

2. FCRV will extend the membership of a single child through the age of 24 if that individual is in the military or a student in college or technical school. This extension ceases upon leaving college, release from the military, marriage, or lack of application to the State/Provincial Director EACH year for a membership extension. At the end of the extension period the member must pay for a renewal at the going rate.

### **Disaster and Safety Awareness Training**

Happy Spring Everyone,

I am hoping camping season is just around the corner for everybody.

I am sure everyone has or is in the process of checking out and preparing their RV's, campers and tow vehicles for the upcoming season.

One of the things most overlooked in our RV's, campers, vehicles and even our homes are fire extinguishers. There are approximately 20,000 RV/camper fires per year.

Fire extinguishers come in many different types, styles, and sizes. No matter what fire extinguisher you have they should be inspected once a year by a fire and safety dealer or business. You should also perform a monthly check on your extinguisher yourself.

The most common fire extinguisher for RV's, campers, vehicles and homes are an ABC rated dry chemical fire extinguisher in a 2 1/2, 5, or 10 pound size.

It is also recommended that you have 3 fire extinguisher in your RV or camper. One near your exit/entrance door, a second one in your bedroom area, and a third extinguisher in one of your outside storage compartments.

If you need to purchase a fire extinguisher, they are available on Amazon, most any box store, or from a fire and safety dealer. Some of the more common top brand names are Amerex, Badger, H3R Performance, First Alert, and Kidde. Try to avoid buying extinguishers with plastic tops; more and more places are refusing to inspect and refill this type. Most all fire extinguishers when purchased come fully charged and ready to be placed in service.

These are just some highlights of basic fire extinguisher information. If you need more information or details, feel free to contact me.

### **Plastic Cap Recycling Project**

Ready to get involved in a recycling project that is good for the environment? Green Tree Plastics located in Evansville, IN will recycle plastic caps into park benches. All we do is collect, sort, and weigh the plastic caps! Some of us are aware of this project as FCRV in Indiana and Illinois are two states that have had success in recycling and purchasing park benches. There is an additional cost depending on what type of bench we choose which can be accomplished with fundraising.

Our goal is to provide a park bench to the three fairgrounds that have hosted our district campouts for many years: Northern District at Gladwin Fairgrounds; Southeast District at Springfield Oaks 4H Fairgrounds; and Blue Water District at Eastern Michigan Fairgrounds.

Just in the short time we started collecting, we have several boxes full! We will talk about this more during the 2021 MSA State Spring Campout. This is an easy project and will be fun to see what we can do to recycle and turn into a useable product. Please start saving plastic caps from various products that would normally be put in the trash! A list of the acceptable (and NOT acceptable) caps are included in this newsletter.


