It's never too early to start thinking about next year's scholarship application. Some of the requirements to be eligible to apply for a Scholarship: the applicant **or** applicant's parents must attend at least one (1) Michigan FCRV campout this year and camped/stayed overnight one night. The qualifying campouts are: MSA State Spring, MSA State Fall campout and a District campout.

IMPORTANT REMINDER: Teens living at home planning to attend college or a trade school, upon turning 20 years of age, will need to request a 20-year-old honorary membership from the Michigan State Director to apply for a free membership. To be eligible for a National or Michigan FCRV scholarship, you must be a member in good standing. (See policy below)

POLICY-TWENTY YEAR OLD HONORARY MEMBERSHIP

- 1. Any single child of an FCRV member in good standing, may at the age of 20, request of the State/Provincial Director that his/her name be placed on the 20 year old honorary membership list. The name, address, and birth date of the 20 year old will be provided to the national office through the State/Provincial Directors.
- 2. FCRV will extend the membership of a single child through the age of 24 if that individual is in the military or a student in college or technical school. **This extension ceases upon leaving college, release from the military, marriage, or lack of application to the State/Provincial Director EACH year for a membership extension.** At the end of the extension period the member must pay for a renewal at the going rate.

Disaster and Safety Awareness Training

Hi everyone, Happy Fall.

The 2024 camping season for the most part has come to a close. I'm sure there's a few camping left to still enjoy this warm fall weather. I hope it was a safe and enjoyable year for everyone.

My apologizes, I'm writing this article at the last minute and it may be a repeat of information but with all the disasters that have occurred and continue to be ongoing concerns, I thought it may be a good idea to review a few things. Especially since we, here in Michigan, can be victims to mother nature's wrath as well.

For instance, to date (Oct 24) the Michigan DNR and US Forest Service have responded to over 250 wildfires this year, with over a dozen fires currently active. This figure doesn't include what your fire department has been dispatched to.

Along with the wildfires Michigan has, we have been struck by 13 tornado's this year to date with an estimated property damage of over \$54,000,000.00, with 15 injuries and 1 fatality.

With all the possible storms and disasters that may affect us, it is suggested by the professionals, such as emergency mangers, FEMA etc. that we be self-sufficient for 72 hrs. Here are just a handful of simple suggestions to help you plan.

- 1. Keep a supply of non-perishable food and water stored in a safe area of your home for emergency situations.
- 2. It's also suggested to keep some cash on hand as well in case electronic banking is disrupted.
- 3. Keep your generator in good working condition. Test run it on a regular basis with some type of tool or appliance

hooked into it. Store your extra fuel in a proper fuel container and safe location. When running your generator

keep it 20 ft from your residence and away from doors and windows.

4. Make an emergency electronic kit. Keep extra charging adaptors for your cellphones, laptops, tablets, flashlights

etc.

5. For escape and evacuation plans, have more than one escape route from your house, and more than one

evacuation route from your home. When planning evacuation routes keep in mind area bridges, culverts and any

low lying areas that maybe susceptible to flooding.

6. Have a Go Bag, backpack, suitcase etc. packed and easily accessible for yourself, kids, and don't forget about

your pets.

7. Keep a contact list of names, phone numbers, emails etc. to keep family, friends, neighbors updated in case of

emergency.

8. Keep an emergency medical list, health issues, prescription medications, over the counter items, Doctor info,

pharmacy info. and have your medications easily ready if you have to evacuate quickly.

These are just a few highlights of suggestions to keep in mind when planning for the unexpected emergency. More detailed information can be found from your local emergency management office, local 1st responder agency, FEMA, Red Cross, to name a few.

A reminder to check your fire/smoke/CO2 monitors and alarms and to replace the batteries when the time change occurs.

Now on a very personal note, it's been a very stressful and hectic year for Doreen and I. During her illness, diagnosis, treatment, several hospital stays with numerous battles of pneumonia, and many lung infections and her current recuperation. Her most recent doctor's appointment she is cancer free and in remission. Doreen and I would like to thank all of you for the thoughts, the many prayers and well wishes that we have received. It will be a very good Thanksgiving for us.

For all you snowbirds traveling, safe journeys to you and Happy Thanksgiving, Merry Christmas, and Happy New Year.



Frosted Pumpkin Cookies

Ingredients

Cookie:

Butter | 2 cups

Sugar | 2 cups

Baking Powder | 2 tsp

Baking Soda | 2 tsp

Cinnamon | 1 tsp

Nutmeg | 1 tsp

Eggs | 2

Vanilla Extract | 2 tsp

Pumpkin | 1 can (15 oz)

All-purpose Flour | 4 cups

Frosting:

Butter | 1/2 cup

Brown Sugar | 1/2 cup

Milk | 1/4 cup

Vanilla Extract | 1 tsp

Powdered Sugar | 3-4 cups

Directions

Preheat oven to 350°F.

Beat butter on medium speed for 30 seconds. Add sugar and combine. Add in eggs and vanilla. Then add in the pumpkin. In a separate bowl combine dry ingredients. Slowly add dry ingredients to the butter mixture. Bake for 10-12 minutes.

For frosting, in a small saucepan, melt butter and brown sugar. Transfer to a medium bowl. Stir in milk and vanilla. Beat in powdered sugar until smooth. Spread on cookies and sprinkles with additional cinnamon.
